Public Emergency Alerts At the start of the week, we shared information with you about the new Public Emergency Alert system, which will be tested on Sunday 23 April. This takes the form of a text message, which will sound a siren when it arrives on your phone. These texts could be sent to anyone, anywhere in the UK. If you support patients or clients who are unable to contextualise the test e.g., due to dementia, other cognitive impairment, or some learning disabilities, you may be concerned the test will cause them to become unduly distressed. If you support individuals experiencing domestic violence, they may be concerned the alert will raise awareness of a secret or secondary phone. Refuge have put together this short video which shows how the alerts can be disabled on both Android and Apple phones.

Mental Health & Learning Disability Services – current pressures Yesterday we featured a piece about the pressures our Mental Health & Learning Disability Services are under at the moment. We wanted to expand on and look at how things are across our community MH&LD services. As highlighted Royal Cornhill Hospital has a very limited ability to admit people and those admitted have a very high level of acuity and need to remain in a hospital setting for longer. This in turn has a great impact on our community teams who are working exceptionally hard to keep people safe and well at home. As the acuity level increases of those admitted to hospital so does the level of those remaining under the care of our Community Teams. This can be very challenging as teams balance the needs of the individuals with the available resources. Often teams work closely with other agencies and work hard to ensure that everyone gets the care and support they need, however, this is an increasingly difficult task.

As with other areas of health & social care we lack staff across all our disciplines and as a result those who are here, doing the work every day, are facing an enormous ask and we would just like to put on record our thanks to all the teams who are working so very hard.


Upcoming Brew & a blether sessions The next Brew & a blether sessions will take place as follows:
